





Q3: What secondary school are you attending / did you attend? (only one answer is possible)





Q5: Have you received any information or support about your options after school? (Multiple answers possible)




Q9: Have you already decided what to do when you leave school? / Had you already decided what to do when you left school? (Only one answer is possible)

Q11: I am currently living... (Only one answer is possible)





Conclusions

- Most students today get the information from their teacher or parent, except for in NI where they also got information in a transition program.
- 2. In total **students don't feel very prepared to adult life**. Only 2,3. In NI they felt more prepared though 2,8 on a scale 1-4. We assume this is thanks to the transition program.
- 3. In total, the people who answered the survey are **medium happy with the help the have received**. 2,75 on a scale 1-4. Here again; one country stands out: NI being more happy with the help they received. We assume this is thanks to the transition program.
- 4. Less people in NI are unsure what to do after school. We think this also is thanks to the transition program.
- 5. On the question how satisfied they are with their plans after school, NI stands out with having people more satisfied with their plans. Probably because of the transition program.
- 6. The transition program in NI seems very fortunate
- 7. On the question; what kind of information which would have been helpful, all the subjects where valued high (between 30-70%). **Our conclusion is that all these subjects should be included in our recourse that the STARS-project develop**. The subjects are:
 - What are my options after school
 - How to apply for a job
 - Acceptable workplace behyviors
 - How to handle money
 - How to manage public transport
 - How to manage activities in daily living (sleep, food, exercise)
 - Work experience with an employer
 - · How to manage close relations
 - How to handle my social life
 - How to access help from support services
 - How to handle moving to my own home
- 8. "Face to face information" and "learning by doing" is how most people prefer to find out information, followed by webpage, and also YouTube, video and social media. We should take this to account when developing the recourse. Our conclusion is that if we develop a webpage with information it is important to combine this page with face to face information and social media. (There are a few local differences. For example in Spain and Ireland less social media mobile apps are requested. We believe this is because parents answered the forms.)
